

## List of Employers in the Auto-inclusion Scheme for Employment Income as at 26 Apr 2012

### Filing of Individual Income Tax Returns

All employees who receive a SingPass letter, IRAS PIN mailer, paper form or SMS to file are required to file the Income Tax Return. If your employer is in the list below, you do not need to enter your employment income and deductions (made through your salary) in your tax return. This is because your employer will submit the information electronically to IRAS on your behalf. The details of your employment income and deductions will be reflected in your Income Deduction Relief Statement (IDRS) when you e-File.

- If the details are not shown in the IDRS and your employer is in the Auto-Inclusion Scheme, you may proceed to e-File by clicking on the box under “Employment” in Section A of the main Tax Form Income Page so that your employment income will be automatically included in your assessment when we receive the information from your employer.
- If you are filing a paper form, you should enter '0' for your employment income and any donations, CPF contributions and life insurance premium deducted from your salary.

However, you do need to declare other sources of income (e.g. rental) and indicate your claims for tax reliefs (e.g. child relief, parent relief) where applicable.
