Status Definition:

<p>1. Issued: You are required to file your Return by the specified filing due date.</p> <p>2. In Process: IRAS is processing your Return. We process tax forms in batches. Most taxpayers should receive their tax bills by September.</p> <p>3. Processed: Return has been processed by IRAS. Notice of Assessment will follow shortly/is issued.</p> <p>4. No-filing Service: You are not required to file your income tax return for the specified Year of Assessment if you only had auto-included employment income and your relief claims are the same as the preceding year.</p>	<p>5. Undelivered: You are required to file your Return by the specified filing due date.</p> <p>6. Not Required: You are not required to file your Return for the Year of Assessment.</p>
