

## IRAS Acceptable Rates for Per Diem Allowances – 2021

These rates are applicable when a Singapore-based employee is sent overseas in year 2021. For overseas employees travelling into Singapore in year 2021 for business trips, the acceptable rate for per diem allowance for Singapore will apply. If an employee is paid a per diem allowance that is more than the IRAS acceptable rate for a particular country/region, the amount in excess of the acceptable rate is taxable in the Year of Assessment 2022.

	Allowance $\leq$ Acceptable Rate	Allowance $>$ Acceptable Rate
Employer's obligation to report in IR8A	No	Yes. Declare the amount in excess of acceptable rate.
Tax impact on employee	Not taxable	The amount in excess of acceptable rate is taxable.

Note:

1. These rates apply to short overseas business trips where the services rendered by the employees overseas are considered incidental to their employment in their home countries.
2. The acceptable rates determined by IRAS are strictly for income tax purpose. The rates do not determine the amount of per diem allowance that employers wish to pay their employees.
