Do I need to file a 2024 Income Tax Return?

You must file an income tax return from 1 March to 18 April if you have received a letter, e-mail, form or an SMS from IRAS informing you to do so.

Otherwise, you may use the <u>filing checker</u> to check if you need to file.


I have income but did not receive any notification to file. Do I need to file?

You need to file a tax return on <u>myTax Portal</u> if your...

Total income is > \$22k or

Employment income is > \$22k or

✓ Net trade income is > \$6k



You are not required to file a tax return as your tax bill will be finalised based on auto-included income and pre-filled reliefs. You can login to <u>myTax Portal</u> from 1 Mar to 18 Apr to verify the details.

Do I need to do anything if my employer said that they have filed for me?

Your employer is most likely under the Auto-Inclusion Scheme (AIS) which means they have transmitted your income information to IRAS.

- Your employment income will be pre-filled in your Income Tax Return.
- You need to submit an Income Tax Return if you have received a notification (via SMS or letter) from IRAS to file.

😢 You **do not** need to key in your employment income.

What should I do if my income/relief is not pre-filled?

If your employer is under the Auto-Inclusion Scheme (AIS), you will have to tick the box under **1. Employment Income and Employment Expenses - Section A** of the main tax form.

Section A

This section does not apply to trade income derived as a Partner/Sole-Proprietor/Self-Employed (e.g. commission agent).

Tick the box if your employment income details from your employer participating in the Auto-Inclusion



Scheme (AIS) are not shown in the IDRS.

For personal tax reliefs, make relief claims under **4. Deductions, Reliefs and Parenthood Tax Rebate** of the main tax form and ensure that you meet the qualifying conditions.


