Making Internet Banking Payment via myTax Portal

Step 1

This e-Service is available for customers of the following banks.

Individual account holders:

DBS/POSB, HSBC, MayBank, OCBC, Standard Chartered Bank, State Bank of India, UOB, RHB, CIMB, BOC and ICBC.

Corporate account holders:

HSBC, OCBC, Standard Chartered Bank and UOB.

To make payment via Internet Banking, click **"Pay Taxes"** under **Account** (top menu).
