Tax Season 2015: Guide on Tax Filing Assistance & Payment

To check if you need to file

- SMS **filetax** <space> **NRIC/FIN** to 91164900 to check if you need to file this year. This service is available until Jun 2015. You will receive a reply from IRAS telling you whether you need to file your tax return this year.

- Preview your tax bill and request an early assessment if you did not amend the 'Income, Deductions and Reliefs Statement' of your tax return
- Compute your estimated tax payable using our tax calculator at www.iras.gov.sg/irasHome/taxcalculators.aspx

Sign up for GIRO to enjoy fuss-free payment of your taxes

You can choose to pay by 12 monthly interest-free instalments or pay in one GIRO deduction. No more worries about tax payment due dates as your tax is deducted from your bank account. Get more details at
