

Guide on Tax Savings, Filing and Payment

Tax Savings

 The personal income tax rate structure has been revised with effect from Year of Assessment (YA) 2012¹. Under the revised tax rate structure, all taxpayers will benefit from a reduction in their taxes.

Filing & Payment Tips

No-Filing Service (NFS)

If you receive a letter or SMS notifying you of your eligibility for NFS, you do not have to file your tax return. Your Notice of Assessment will be sent to you based on the auto-included employment income and your personal relief claims for last

year. However, you have to e-File if you have additional income to declare or wish to make changes to your personal reliefs. Please do so by 18 Apr 2012.

Tax filing notification

If you receive a tax filing notification letter from IRAS, please file by the due date, even if your income is less than \$22,000 in 2011, and/or your employer is in the **Auto-Inclusion Scheme (AIS)**.

- Not sure if you need to file this year? Simply SMS filetax<space>your NRIC/FIN number to 91164900. You will receive a reply from IRAS telling you whether you need to file your tax return this year.
- Is your employer in the AIS? If so, your employment income will be automatically included in your tax return. Check out the list of employers on AIS on IRAS website (<u>www.iras.gov.sg</u> > Quick links > e-Services > Other e-Services > e-Submission of Employment Income).
- Give us your mobile number through myTaxPortal (https://mytax.iras.gov.sg), and receive timely updates/reminders on tax matters.
- Enjoy 12 month interest-free instalment when you pay tax via GIRO. No more worries about tax payment due dates. GIRO your tax, it is convenient and hassle-free. Plus, you may be a lucky winner in IRAS' annual "GIRO Your Tax" Lucky Draws in May 2012 and May 2013! For taxpayers who continue to pay their taxes by GIRO through the same bank account, their chances will double for the Final Draw in May 2013, where they stand to win the top prize of \$50,000 cash.

You can sign up for GIRO easily through the following avenues:

- a. Any AXS station (for DBS/POSB customers);
- b. Online internet GIRO application (for DBS/POSB or OCBC customers);
- c. Complete the payment voucher that comes together with your tax bill (for DBS/POSB, UOB, OCBC and HSBC customers); or
- d. Complete a GIRO application form. The form with return address can be downloaded from www.iras.gov.sg > Quick links > Forms > GIRO Application Forms.
