IRAS obtains the income details of employees who are **NRIC holders** from CPF Board and these income information will be pre-filled at 'Submit Employment Income Records' at [myTax Portal](#) (Online Application). Simply verify and update the records if needed before submitting the income information to IRAS.

The type of employees' data obtained depends on how you submit your employees' monthly CPF contribution details to CPF Board.
