[About the book]

"The Law and Practice of Singapore Income Tax" covers a wide spectrum of topics, from the more general ones such as the framework on tax interpretation, capital allowances, the capital and revenue divide with respect to receipts and expenditures, to specialised and industry-specific topics on unit trusts, banking operations and withholding tax and taxation of non-residents.

"The Law and Practice of Singapore Income Tax" comprises 24 chapters. Each chapter was written by a subject matter specialist or a combined team of a tax lawyer and a tax accountant in their chosen areas of expertise, and edited by a panel of tax experts in their own right.

There are five industry specific chapters covering hedged funds and private equity activities, unit trusts including REITS, banking, insurance operations and wealth management for individuals.

Nine chapters cover the issues and areas most commonly encountered by the tax practitioners. These are the chapters on taxable receipts, deductible expenses, capital allowances, withholding tax, intellectual property, tax treaties, stock options and share schemes, investigations and audits and, appeals and objections.

The other 10 chapters are either issues specific or activities specific. These include chapters on interpretation of laws, source of business income, source of employment income, restructuring, mergers and acquisitions, transfer pricing, financial derivatives,

capital market transactions, relevance of accountancy principles and practices in tax, tax avoidance, and even green taxation.
