





	 Notes: The numbers shown on the top-left hand corner of the list of documents indicate the number of unread documents in each category. Unread documents will be marked with a blue line on the left. Documents listed are pertaining to Years of Assessment (YA) for which you are authorised to view. With effect from 31 Jul 2019, the YA displayed for Certificate of Residence (COR) refers to the Calendar Year preceding it, for which the COR is applied for. For example, YA 2020 refers to the COR applied for the Calendar Year 2019. Prior to 31 Jul 2019, the YA displayed refers to the YA for which the COR is applied for.
