View AEOI e-Service Transaction History

Estimated submission time required is about 5 minutes. Please have the following information ready before using the e-Service:

1. Your Singpass
2. The Reporting SGFI's Singapore Tax Reference Number

Step 1

- Log in via [myTax Portal](#) > Select More > AEOI > **View AEOI e-Service Transaction History**

Step 2

At View AEOI e-Service Transaction History landing page,

- The last 5 transactions performed will be displayed.
- If you want to search your FI's AEOI e-Service transaction history, select the textbox/ calendar icon.



- If transaction is performed by authorised user (i.e. a user who is authorised by the FI's Corppass admin via Corppass), it will be displayed as "**Staff**" under "Role"
- If transaction is performed by 3rd Party User (i.e. a third-party agent that is authorised by the FI's Corppass admin via Corppass), it will be displayed as "**Third Party Staff**" under "Role"
