## Step 2

At View AEOI e-Service Transaction History landing page,

- If you want to search your FI's AEOI e-Service transaction history, select the textbox/ calendar icon.

- If transaction is performed by authorised user (i.e. a user who is authorised by the FI's Corppass admin via Corppass), it will be displayed as "**Staff**" under "Role"
- If transaction is performed by 3rd Party User (i.e. a third-party agent that is authorised by the FI's Corppass admin via Corppass), it will be displayed as "Third Party Staff" under "Role"
