

GIRO Deduction Date

- 1. GIRO deduction date is on the 25th of the month of the tax is due See examples 1 and 2
- 2. If the 25th is a weekend or public holiday, GIRO deduction will be on the next working day
- 3. For Payers who filed <u>after</u> the due date (i.e. filed on 16th of the month to 15th of the following month), deduction will be on the next deduction date See example 3
