Vendors are to fulfil the [requirements](#) before they are included to the list. Please note that the list is solely for reference purposes.

You may contact your vendor directly to check if your current payroll software supports IRAS' file format and specifications on API submission of employment income records to IRAS, or to obtain the steps for submission using your software.
